I fully understand and agree to the following matters:

1. My child promise to abide by the relevant laws and regulations of the university and overseas studying university during the overseas study and internship, and will never do anything that damages the reputation of the university and overseas studying university. Any violation will be punished in accordance with relevant government or university regulations.
2. Except for force majeure factors, my child will never give up, end early or interrupt overseas study and internship for any reason. My child will return to Taiwan on time after the courses end, and there will never be any cases of staying in the overseas country without returning to Taiwan.
3. My child will handle personal matters such as visas, course selections, credit waiver, air tickets, and insurance on his/her own.
4. Visa approval is subject to the review results of the local government of the country of study. If the student is unable to study at the original university where he/she was admitted due to visa issues, other university will not be substituted for the student to study and the student will be transferred to the Office of Research and Development to assist in domestic internship selection. If the student is unable to go abroad smoothly due to temporary major circumstances such as epidemics or natural disasters, follow-up procedures will be handled in accordance with university decisions.
5. My child promises to pay attention to his/her own safety at all times while going abroad, not to go to dangerous places, continue to abide by the university's student affairs regulations "Safety Precautions for Students of National Kaohsiung University of Hospitality and Tourism", and keep in touch with relevant university personnel (homeroom teachers, department offices, Office of International Affairs, etc.) at all times.
6. My child and I have understood and agreed to the relevant content of this overseas study and internship program, including fees (tuition fees, living expenses and other derivative expenses), course content, internship content (paid with salary or subsidies or not), etc.
7. **(For Taiwanese nationality only)** According to Article 4, Paragraph 1, Subparagraph 3 of the Regulations for Exit of Draftees, the period approved for the exit of a draftee shall not be longer than one (1) year if the draftee is a student who has applied for the exit on the grounds of taking

a research project, foreign studies, performance, visit, competition event, training or field practice as assigned or recommended. In addition, the return deadline shall not exceed the deadline of deferred conscription. To apply for exit on the grounds of taking a research project or foreign studies, it will be subject to twice for each program.

8. **(For Taiwanese nationality only)** If the student receives middle-low-income subsidies from various county and city government, please be sure to ask the county and city government about the impact of the situation of "long-term non-residents in Taiwan" on the rights and interests related to receiving subsidies. This consent form can only be submitted after consideration and consent.
